- 6. Dr Jan Lukas Robertus: Discovery of pre-neoplastic signature in mesothelioma





After the presentations, a lovely lunch and refreshments were provided and it gave all attendees a chance to chat and to get to know each other and, of course, the opportunity to ask the speakers any questions on the presentations.

After lunch, we were taken for a tour of the laboratories to visit where the physical work takes place.

We had the privilege to be able to look at tissues and cells under extremely hi-tech microscopes that are used to examine many different types of cancer cells and tissue biopsies which ultimately lead to a diagnosis.



We also had the opportunity to look at some jaw dropping equipment that is used at the university. A fantastic day was had by all and it was great to see patients supporting each other and making friendships.

## **The Asbestos Victims Support Groups Forum UK**

Our charity is a member of the Asbestos Victims Support Groups Forum UK, which campaigns on behalf of asbestos victims to protect their rights.

We asked Joanne Gordon, the chair of the Forum, to give us a summary of their current campaigns. Joanne replied as follows:

"The All-Party Parliamentary Group, Asbestos sub-committee, met on the 16th January 2023. It was a well attended meeting. When you have to scroll between screens you know the attendance is good!

### **Proposed seminar**

Thanks to the good relationship with the Forum and the TUC, we are able to bring our campaigning issues to parliamentarians and a wider audience.

The first item on the agenda was a planned seminar in Parliament. We are constantly writing to MPs about various issues, without the opportunity for dialogue. A seminar in parliament would give MPs or their researchers the opportunity to ask questions. This was agreed at the meeting.

#### **Brexit**

There was much concern at the meeting about The Retained EU Law (Revocation and Reform) Bill which may see our hard fought asbestos laws weakened. In a briefing paper prepared by the TUC the paper states:

"The Bill proposes to automatically sweep away thousands of pieces of legislation and upend decades-worth of case law. It is striking that ministers have yet to explain which laws they intend to retain, to amend or allow to expire. Indeed, there even remains uncertainty about whether government knows which laws are affected."

The not knowing makes this fight particularly difficult but it is one we need to be vigilant about. Already thousands of people are dying due to the deadly legacy of asbestos. We need to ensure that our legislation continues to protect anyone who could come in contact with asbestos and to make sure that any Trade Agreements do not allow asbestos products to be brought into the UK."

## **REMEMBERING NELLIE KERSHAW**

2023 is the 99th anniversary of the passing of Nellie Kershaw, the first recorded death from an asbestos related disease. She was aged just 33.

In his seminal work Magic Mineral to Killer Dust 1 and for which much gratitude should be given, Geoffrey Tweedale discusses the poignant story of Nellie's short life. Born at the end of the 19th Century in Rochdale, Lancashire, Nellie entered the workforce at the age of 12. This is astonishing but was commonplace, being standard school leaving age at the time.

Nellie's first months of working life were spent in a cotton mill. She soon left and joined the thriving asbestos industry, where she remained employed for 14 years. Nellie married and had become a parent, when she moved to work for the infamous Turner & amp; Newall company. However, the employer was not considered notorious at the time. Indeed, it was in the process of becoming the world's largest asbestos manufacturer.

Not long after starting her job at Turner's, Nellie complained of respiratory symptoms. She consulted a doctor and was found to be suffering from tuberculosis but her physician went further, in 1922 diagnosing 'asbestos poisoning'. This was a first and brought with it the full vehemence of the Turner company. The employer was outraged at Nellie's doctor, who refused to be cowed by corporate bullying. 1 Oxford University Press, 2000.

A form of statutory sick pay was available, but the government department refused, passing responsibility onto the employer. Nellie's thwarted attempts to secure what today would be considered her legal right to benefits and compensation were only just beginning. Turner's argued that asbestosis was not a recognised compensable disease and insisted their insurers reject the claim. Nellie deteriorated and was off work on unpaid sickness. Her pleas to her employer for modest compensation went unanswered. Finally, towards the end of her life, the state benefits scheme of the time paid Nellie seven shillings a week. Turner's paid nothing and continued the insult to Nellie's husband, refusing any contribution to the cost of her funeral. However, the authorities, aware of the growing asbestos menace, would not be guite so dismissive in the Kershaw family's guest for a form of justice. Not being satisfied with the original post mortem findings, the Rochdale Coroner asked pathologist W E Cooke, to further examine the lung tissue, a UK first for a deceased asbestos worker. His report was published in the British Medical Journal. He noted that the entire surface of the lining of Nellie's right lung was thickened. The lung itself was 'to a large extent airless, the lung tissue being replaced by fibrous tissue.' The left lung was blackened and showed evidence of significant fibrosis. In other words, Nellie's intense exposure to asbestos fibres had choked her slowly, to a premature death. Cooke gave evidence to that effect at the Coronial Inquest and coined the medical term 'asbestosis'.

This was a period before mesothelioma was recognised. Asbestos workers like Nellie Kershaw simply did not live long enough to develop the tumour. Instead, an asbestos victim suffocated, quite often while still in their twenties. Nellie would succumb to asbestosis, a few months before the demise from natural causes of Sir Samuel Turner, the founder of her employer's asbestos business and the son of a Lancashire industrialist. Turner adopted the role of Victorian paternalist and his philanthropy was rewarded with a knighthood. He lived into his eighties and his death was marked with the district turning out to pay their respects. A marble monument was commissioned to mark Turner's place of rest.

Nellie was buried in an unmarked pauper's grave. However, Nellie's courage and fortitude, the injustice done to her and other asbestos workers have left a legacy, which survives almost a century later.



## **HODGE JONES & ALLEN**

Patrick Collier, aged 74, has developed asbestos related pleural thickening due to being exposed to asbestos dust and fibres when working as a painter and decorator. Lorna Webster, a Partner from one of London Asbestos Support Awareness Group's panel law firms, Hodge Jones & Allen, has successfully secured compensation for his asbestos disease.

Patrick Collier, aged 74, has developed asbestos related pleural thickening due to being exposed to asbestos dust and fibres when working as a painter and decorator. Lorna Webster, a Partner from one of London Asbestos Support Awareness Group's panel law firms, Hodge Jones & Allen, has successfully secured compensation for his asbestos disease.

Between 1979 and 1997 Patrick worked for Newmans (Byfleet) Limited, a decorating company that was based in Hounslow, London. Patrick's work involved him preparing and scraping over surfaces made from asbestos materials, including roofs, soffits, fascias, lagging and guttering, before they could be painted. He typically used a scraper, wire brush and sandpaper. Each time he did this work, asbestos dust was being released and Patrick was breathing in those fibres. Patrick would typically be doing this work all day long or in some jobs he would spend days or even weeks continuously doing this preparation work. His employers failed to provide any adequate protection or warning to him about the dangers of working with asbestos materials.

The insurers acting on behalf of Newmans (Byfleet) Limited made no attempt to settle Patrick's case and so Court proceedings were commenced in order to achieve justice and a financial settlement for Patrick. Court proceedings were issued in the specialist asbestos disease section of the Royal Courts of Justice in London. Lorna Webster was able to obtain a significant settlement for Patrick.

Pleural thickening is an asbestos related disease that affects the lungs. The disease is often caused by asbestos exposure, with shortness of breath being the main symptom. Patrick's condition ultimately led to him prematurely giving up his work as a part-time caretaker due to the breathing difficulties he was experiencing. He simply could not manage the physical side of the caretaking work he had been doing, and which he enjoyed, for so many years. The compensation obtained for Patrick included an element to cover his loss of earnings into the future up until the date he would have given up that work in any event.

#### Lorna Webster said:

"Asbestos diseases often take decades to appear after the initial exposure and many tradespeople such as painters and decorators just like Patrick, as well as plumbers, carpenters and electricians, are affected by these conditions. Not everyone who has been exposed to asbestos dust will develop an asbestos related disease but for those who do, it is vitally important they seek assistance and support, including for DWP benefits and compensation. London Asbestos Support Awareness Group and the specialist solicitors approved by London Asbestos Support Awareness Group can assist with the whole package of providing practical support and assisting with obtaining benefits and compensation".

#### Patrick said:

"I loved my caretaking job and had been doing it for many years, but, unfortunately, I had to give it up due to the health issues my asbestos disease caused me. If Newmans (Byfleet) Limited had provided me with the correct protection and training, I wouldn't be suffering from this disease. The compensation payment has allowed me to get back to where I would be financially if I hadn't had to give up my caretaking job, although the payment obviously cannot give me back my health. I will use the payment to cover my lost wages from being forced to give up my work and for aids and appliances to make my everyday life easier. I hope my case inspires others throughout the country to seek help if they are suffering from an asbestos disease. I wasn't sure if a claim could be pursued because Newmans (Byfleet) Limited were no longer trading but the claim could be pursued against their insurers. My message to other people affected by asbestos exposure is simple – don't suffer in silence; if you are worried about your health speak to your GP; if you get a diagnosis of any asbestos disease, speak to an experienced solicitor to find out your rights for benefits and compensation."

Many clients who come to London Asbestos Support Awareness Group for help have been affected by mesothelioma. However, the charity offers support to anyone who has been affected by any asbestos related condition.



## **Asbestos in Schools**

Widower of a school teacher who died from an asbestos cancer succeeds in legal action against Surrey County Council

Unfortunately, asbestos products were used in many schools built between the period 1950s to the 1970s. Leigh Day lawyers have dealt with many cases representing teachers and pupils who were exposed to asbestos in those schools

A recent legal case involved a PE teacher who saldy died from mesothelioma at the age of 78.

Julia Browne was Head of Physical Education (PE) at St Teresa's Secondary Girls School, Green Street, Sunbury on Thames (now called St Paul's Catholic College) from September 1971 to June 1979. She was diagnosed with mesothelioma in October 2021.

Before she died, Julia had instructed Harminder Bains, Joint Head of the Asbestos and Industrial Injuries Department at Leigh Day to investigate and advise her regarding her claim for compensation.

For a period of five to six months between 1972 to 1974 Julia was exposed to asbestos dust when building works were undertaken at the school in the changing rooms, assembly hall, the gym and other areas.

After considerable research, Harminder obtained documents which showed that there was building work undertaken in the school as a result of cracks appearing in the ceiling, due to the use of "high alumina" concrete when the school was built.

During the building works asbestos was found at the school. Harminder then obtained evidence from other teachers who corroborated Julia's evidence and Harminder issued a court case in the Royal Courts of Justice, Strand, London on 16 February 2022.

Surrey County Council served a defence denying almost every allegation and even denied that it owned or controlled St Teresa's School at the time of Julia's employment.

The Council did not admit that asbestos was disturbed during the building works and requested Julia "to prove" her claim. The case was set down for a three-day trial which was due to start on 1 December 2022.

Sadly, Julia died just over a month before trial. Her husband Peter Browne asked Harminder to keep the trial date as he did not wish the case to be delayed as this would only add to his distress. The Coroner agreed to fast track the Inquest so that the trial date could stay in place.

The case was prepared for trial and Peter and Julia's teacher colleagues were ready to attend court in support of Julia's evidence. Faced with the prospects of a trial, the council made a substantial offer of compensation 13 days before the trial was due to start. The Council agreed to also pay Peter's legal costs. Peter accepted the sum offered. Peter Browne said:

"My wife died in October 2022 shortly before the successful outcome of a legal action for mesothelioma against her former employers. "Our case was handled by Harminder Bains at Leigh Day. I could not commend Harminder too highly. She demonstrated tenacity and conviction from the outset, inspiring a growing confidence in what initially appeared to us to be an insurmountable mountain to climb with my wife's exposure to asbestos dating back almost 50 years.

"These same qualities, and the detail and strength of the case compiled by Harminder, left the Defendant with no option but to concede the case prior to the trial by way of an out of Court settlement".

Harminder Bains said:

"Julia was a PE teacher who was exposed to asbestos whilst teaching children. This is intolerable and should not have occurred. She should be alive today continuing to enjoy her life with her beloved family. Thousands of schools in England and Wales contain asbestos and sadly Julia is not the only teacher whose life has been cut short as a consequence of this deadly substance. Sadly as a result of successive Government's failure to remove the asbestos from the schools teachers and pupils will continue to be exposed."
